Pursuant to Article 26 of the Law on Marine Fisheries (Official Gazette of the Republic of Montenegro 55/03), the Ministry of Agriculture, Forestry and Water Management has issued the

**R U L E B O O K**

**ON METHOD, TYPE AND QUANTITY OF FISHING GEAR AND EQUIPMENT PERMITTED FOR USE IN SPORT-RECREATIONAL FISHING AND THE FORM, NUMBER AND CONTENTS OF THE SPORT FISHING PERMIT**

*Rulebook was published in the Official Gazette of the Republic of Montenegro*

*10/2004 of 19 February 2004*

**Article 1**

Sports fishing may be done only with the following means: line, tended line, one fishing rod, an underwater gun without explosive charge, harpoons, longlines of up to 150 hooks and trident, with a lantern of up to 400 candles or without it, one trap, using a boat propelled by oars, sails or power engine.

For joint sports fishing (of members of sport fishing associations, tourists and other, sports competitions) larger fishing sports and other boats may be used as well.

Collecting of shellfish, sponges and corals may be done by the following hand tools: rake, pliers and diver's knife.

**Article 2**

In fishing with line, the hooks with gap width not less than 7 mm may be used, and in fishing with floating line, the gap width must not be less than 9 mm.

**Article 3**

A person engaged in sport fishing with an underwater gun may move in the water and under the sea only by his/her own power and on that occasion he/she must have a signal buoy on the surface.

**Article 4**

Hook size is measured by the band width measured by the outer edge, i.e. the gap between the hook and the shank.

**Article 5**

The permits for sport-recreational fishing is issued by the local government authority in charge of sport and recreation matters on the permit form printed with this Rulebook that it makes integral part of (Annex 1).

**Article 6**
