Pursuant to Article 11 paragraph 8 of the Law on Foreign Trade in Arms, Military Equipment and Dual Use Goods (Official Gazette of Montenegro, 80/08), Ministry of Economic Development hereby issues the

## **RULEBOOK**

### **On Entry Application Form for the Register of Entities Conducting Foreign Trade in Controlled Goods and the Form of and the Method of Keeping the Register**

#### **Article 1**

This Rulebook shall regulate the application form submitted by a physical i.e. legal entity for entry into the Register of entities conducting foreign trade in controlled goods (hereinafter: the Register), as well as the form of and the manner of keeping the Register.

#### **Article 2**

The application form submitted by a physical i.e. legal entity (hereinafter: Entity) for entry into the Register shall be printed as an attachment to this Rulebook and shall form an integral part thereof.

#### **Article 3**

The Register shall include the following data:

- name and surname / name of organization
- address/ seat;
- unique personal number/ tax identification number (PIB);
- telephone number, e-mail, web address;
- type of controlled goods;
- name and surname of the authorized person;
- number and date of the Decision on entry in the Register ;
- number and date of the Decision on deletion from the Register;
- alternation of data referring to foreign trade in controlled goods;
- and other data.

#### **Article 4**

235. RULEBOOK ON ENTRY APPLICATION FORM FOR THE REGISTER OF ENTITIES CONDUCTING FOREIGN TRADE IN CONTROLLED GOODS AND THE FORM OF AND THE METHOD OF KEEPING THE REGISTER

The Register shall be kept in a form of a hard cover book and contain numbered pages. The cover of the book referred to in paragraph 1 hereof shall contain the following text: "The Register of Entities Conducting Foreign Trade in Controlled Goods".

The first page of the book referred to in paragraph 1 hereof shall include the following text: "This Register shall contain 100 pages" and be signed by an authorized person and stamped by a state body competent for keeping the Register.

**Article 5**

The Register shall be filled in legibly.

The data from the Register shall not be deleted and the incorrect data shall be crossed out with a single red line, be timed with the date of correction and signed by a person authorized to make such a correction.

**Article 6**

The Register Form shall be printed as an attachment to this Rulebook and shall form an integral part thereof.

**Article 7**

The Rulebook on the Method of Keeping the Register of Entities Conducting Foreign Trade in Controlled Goods (Official Gazette of the Republic of Montenegro 12/05) shall be repealed on the day of entry into force of this Rulebook.

**Article 8**

This Rulebook shall enter into force on the eighth day following that of its publication in the Official Gazette of Montenegro.
