The Ministry of Foreign Affairs of Montenegro, after the proclamation of independence of Montenegro, started the activities on defining the list of international multilateral agreements which the former state union of Serbia and Montenegro was a member to, and in which the competent authorities of Montenegro show interest for the opening of the process of succession. The Succession was done pursuant to the Decision on the Proclamation of Independence of the Republic of Montenegro (OG of MNE 36/06) and the 1978 Vienna Convention on Succession of States in Respect of Treaties.

In the first phase Montenegro started the procedure of accession to relevant international instruments i. e. the founding documents of international organisations.

In the second phase, notifications on succession were deposited in relation to international treaties deposited with the Secretary General of the United Nations which the former state union of Serbia

and Montenegro (i. e. FRY) was a member to. The notification on succession for international treaties of the UN was also related to the reservations that the former state union submitted or inherited.

In the third phase, the procedure of accession to multilateral conventions deposited with individual countries was started.

## **2) INTERNATIONAL MULTILATERAL AGREEMENTS DEPOSITED WITH THE SECRETARY GENERAL OF THE UN**

4. *Protocol concerning Specially Protected Areas and Biological Diversity in the Mediterranean, adopted in Barcelona on 10 June 1995, replacing the Protocol on the Areas of the Mediterranean under Special Protection, adopted on 3 April 1982, the Protocol on Prevention of Pollution of the Mediterranean Sea by Trans-boundary Movements of Hazardous Wastes and their Disposal, adopted in Izmir on 1 October 1996.*

The instrument of accession to the International Olive Oil and Table Olives Agreement, adopted in Geneva on 29 April 2005, was deposited on 13 November 2007, by which Montenegro became a member of the International Olive Council.

#### **i) Depository – the Government of Germany**

Montenegro deposited an Instrument of Accession to the **Convention on the Conservation of Migratory Species of Wild Animals (OG of MNE 6/08-147)** on 9 December 2008. The Convention, in accordance with Article XVII paragraph 2 thereof, enter into force for Montenegro on 1 March 2009.

Montenegro is a signatory to the **Statute of the International Organisation for Renewable Energy (IRENA)** since 26 January 2009.

#### **j) Depository - Government of France**

Notification of succession in relation to the *The General Framework Agreement for Peace in Bosnia and Herzegovina* (the Paris Peace Accords) was submitted on 2 November 2007.

The instrument of accession to the Agreement on the Establishment of Organisation for Vine and Wine and was delivered on 3 March 2008.

#### **k) Depository – Government of Monaco**

The instrument of accession to the Convention on International Hydrographical Organisation – IHO (OG of MNE 5/68) was deposited on 25 July 2007. In order for Montenegro to become a member of this organisation it needs to be accepted by the 2/3 of the IHO members. Until 5 May 2009 out of 52 necessary positive answers Monaco received 47 notifications on acceptance of the Montenegrin accession.

The instrument of accession to the *Agreement on the Conservation of the Cetaceans of the Black Sea, the Mediterranean Sea and Contiguous Atlantic Area ACCOBAMS* (OG of MNE 07/08-1) was deposited on 18 May 2009 and entered into force for Montenegro on 1 August 2009.

#### **l) Depository – Government of Mexico**

On 30 July 2008 Montenegro deposited the notification of succession with the Government of Mexico in relation to the Convention Amendign the Warsaw Convention for the Unification of Certain Rules relating to International Carriage by Air (OG of SFRY - 3/78-285 ).
